DESCRIPTION

NeoCera™ Cream is a fragrance-free, non-comedogenic water soluble dressing formulated for the management and relief of irritation experienced with various types of dermatoses, including atopic dermatitis and allergic contact dermatitis.

INGREDIENTS

Carbomer, dimethicone, ethylparaben, glycerin, glycyrrhetic acid, hydroxypropyl bispalmitamide MEA (ceramides), methylparaben, palmitamide MEA, petrolatum, phenoxyethanol, polysorbate 20, propylene glycol, propylparaben, purified water, sodium hydroxide, stearic acid, trolamine, vitis vinifera (grape) seed extract.

INDICATIONS FOR USE

NeoCera Cream is indicated for management and relief of irritation experienced with various types of dermatoses, including atopic dermatitis and allergic contact dermatitis.

CONTRAINDICATIONS

Known hypersensitivity to any of the NeoCera Cream ingredients.

PRECAUTIONS:

General

NeoCera Cream is to be used only as directed by a healthcare practitioner. It should not be used to treat any condition other than that for which it is prescribed. **For external use only.** Avoid contact with the eyes, lips, and other mucous membranes. Exposure of the eye to NeoCera Cream may result in reactions such as stinging and ocular irritation.

If a reaction to NeoCera Cream suggesting sensitivity or chemical irritation occurs, use of the medication should be discontinued and the prescribing healthcare practitioner consulted. This product provides no sunscreen protection. Use of sunscreen products and protective clothing over treated areas is recommended when exposure cannot be avoided.

KEEP THIS AND OTHER MEDICATIONS OUT OF THE REACH OF CHILDREN.

DIRECTIONS FOR USE

Unless otherwise directed by a prescribing healthcare practitioner, NeoCera Cream should be applied to affected area three times a day (or as needed). NeoCera Cream should be rubbed into the skin until it is completely absorbed.

Cleanse affected area with a mild or soap-free cleanser before applying NeoCera Cream.

Non-astringent moisturizers may be used if necessary.

HOW SUPPLIED

NeoCera Cream is supplied in a 450 gram tub with pump top bearing the Item Code 23710-210-45, a 3 gram professional sample plastic tube (23710-210-03) and a 450 gram professional sample tub with pump top (23710-210-45).

Store at controlled room temperature 15° to 25°C (59° to 77°F).
